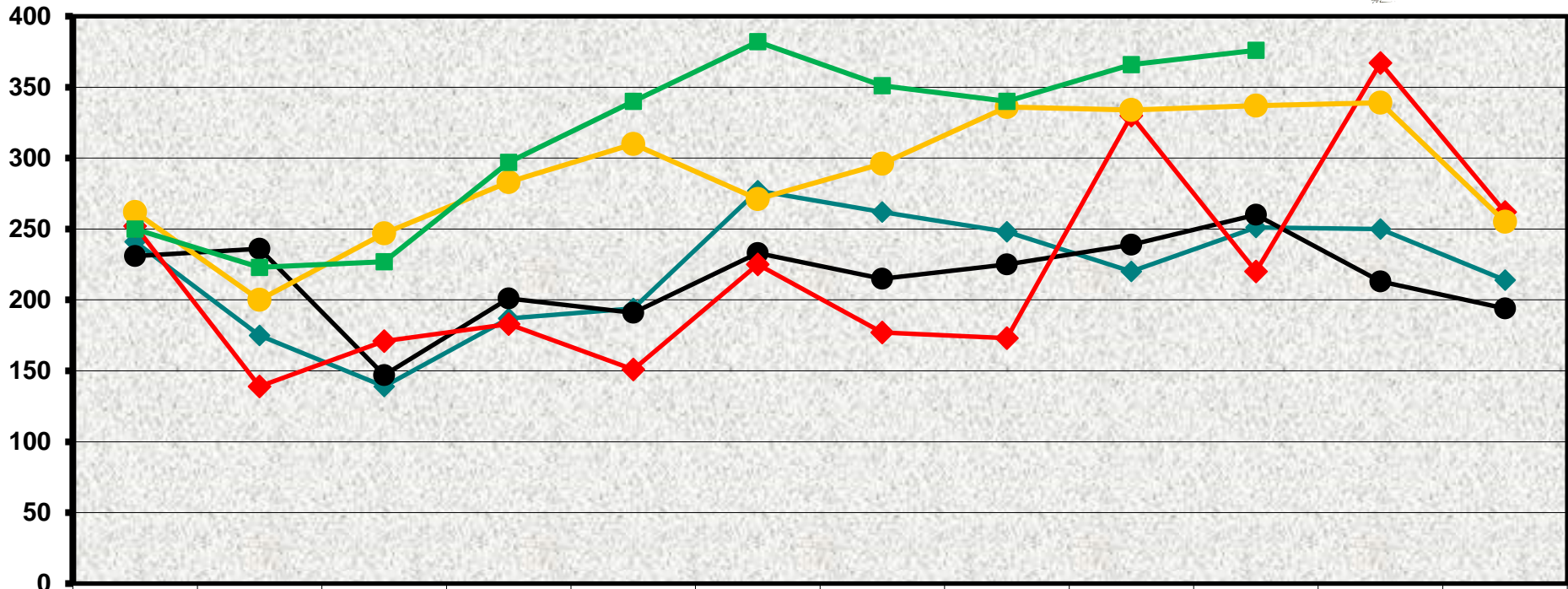

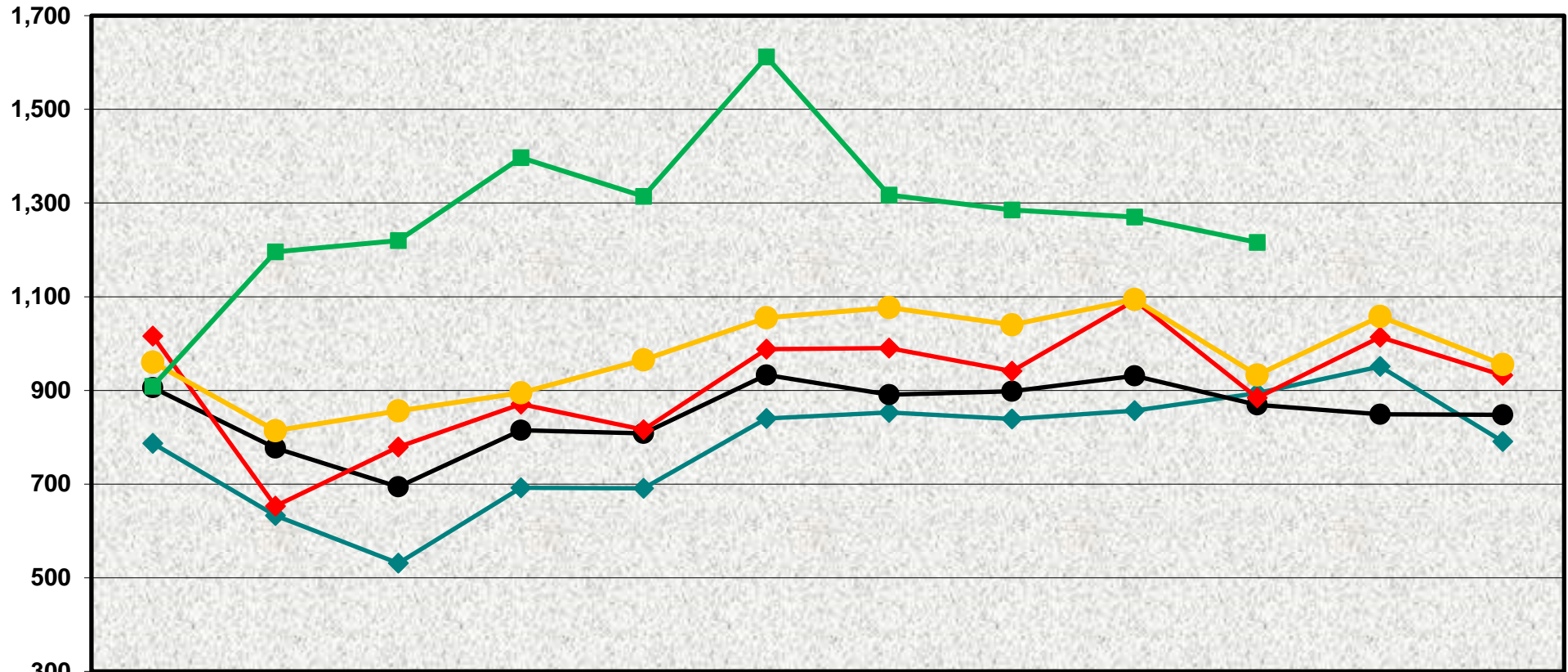

SINGLE FAMILY - DETACHED AND ATTACHED PERMITS**



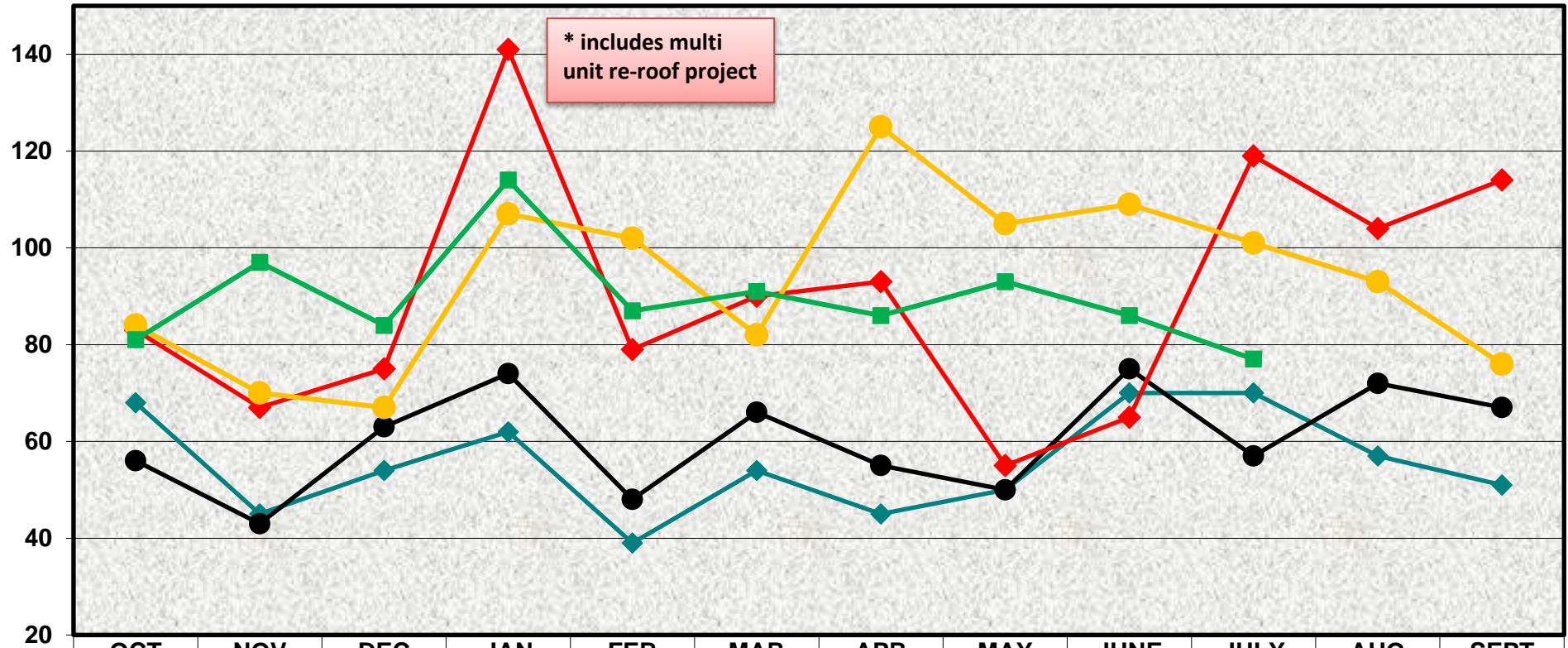

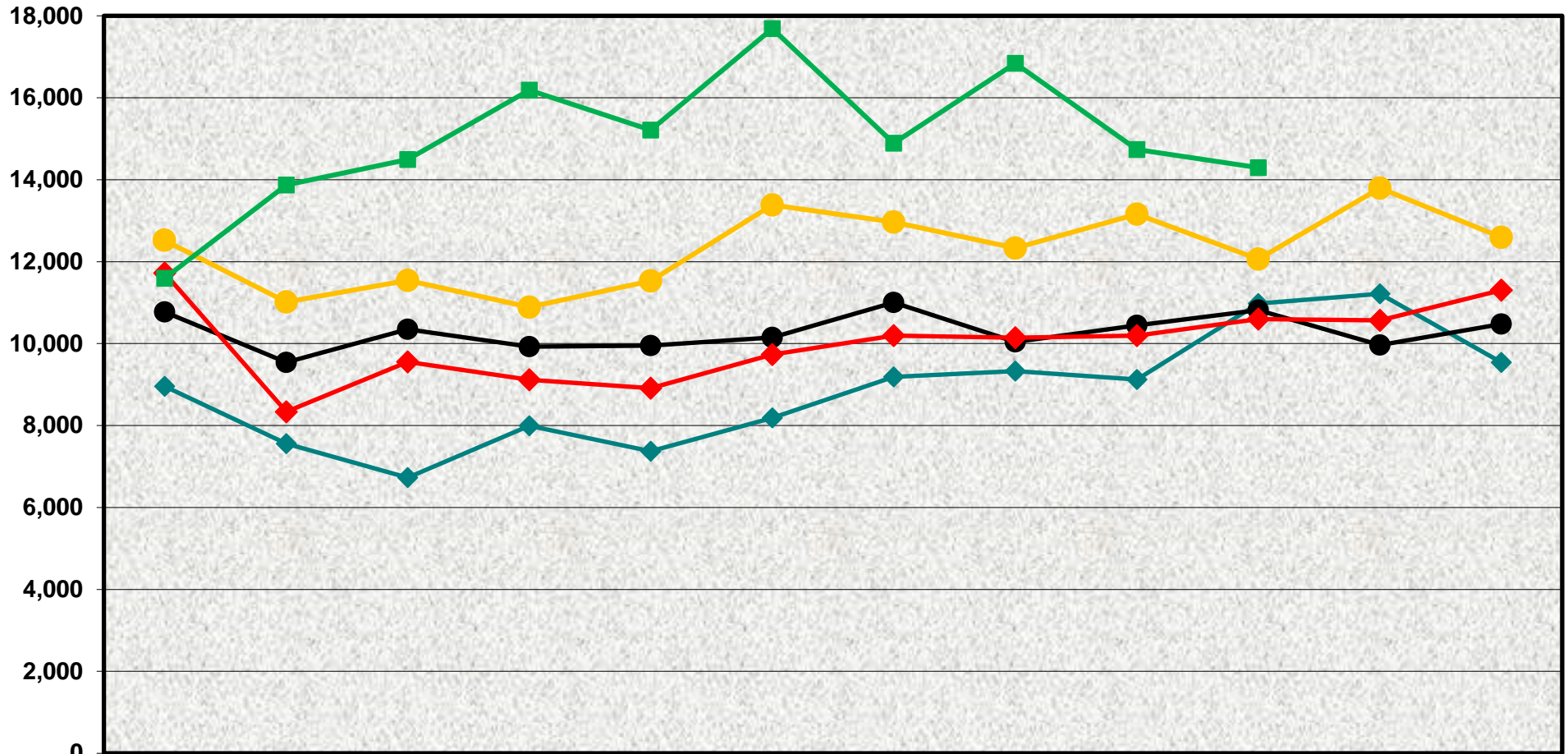
