



NOTICE TO OUR CUSTOMERS

CONSUMER PRICE INDEX ADJUSTMENT EFFECTIVE OCTOBER 1, 2022

In compliance with County Ordinance 2022-37, the water, wastewater and reuse rates, along with Unit Connection Fees, will increase by 8.5%. This increase is based on the current Consumer Price Index of all Urban Consumers (CPI-U) as recorded by the Bureau of Labor Statistics of the U.S. Department of Labor for July 2022. This increase will be seen on your first full billing cycle after the effective date.
