The County's Economic Development Office, St. Johns County Chamber of Commerce, and other resource partners coordinate efforts to support your small business. This checklist provides an introductory guide on zoning permits, business tax receipts and other state business regulations.

PLANNING AND ZONING

Check with your local zoning office for information regarding the correct steps to obtain your permit. If you will be operating your business out of your home, a permit is required in St. Johns County.

Payment of the Local Business Tax is required to conduct business in St. Johns County. It is due annually on October 1, coinciding with the beginning of the fiscal year, ending September 30.
