More than 20 burn pit and other toxic exposure presumptive conditions based on the PACT Act. This change expands benefits for Gulf War era and post-9/11 Veterans.

HEALTHCARE ELIGIBILITY AND ENROLLMENT IN VA


If you meet the requirements listed here, you can get free VA health care for any condition related to your service for up to 10 years from the date of your most recent discharge or separation date. You can also enroll at any time during this period and get any care you need, but you may owe a copay for some care.

At least one of these must be true of your active-duty service:

■You served in a theater of combat operations during a period of war after the Persian Gulf War

<u>OR</u>

■You served in combat against a hostile force during a period of hostilities after November 11, 1998



And this must be true for you:

■You were discharged or released on or after October 1, 2013

What if you were discharged or released before October 1, 2013

At least one of these must be true of your active-duty service:

■You served in a theater of combat operations during a period of war after the Persian Gulf War

OR

You served in combat against a hostile force during a period of hostilities after November 11, 1998

And both of these must be true for you:

- ■You were discharged or released between September 11, 2001, and October 1, 2013, and
- You haven't enrolled in VA health care before



If you meet the requirements listed here, you can receive care and enroll during a special enrollment period between October 1, 2022, and October 1, 2023.
