Section 6. This act shall take effect immediately upon becoming a law.

ARTICLE VI. DRAINAGE DISTRICTS

DIVISION 1. ELKTON

CHAPTER 7590—(No. 332)

AN ACT Ratifying, Validating and Confirming the Creation and Organization of a Drainage District in St. Johns County, Florida, Known as Elkton Drainage District Number One, Created and Organized Under the Provisions of Chapter 6457, Laws of Florida, Acts of 1913, Approved June 7th, 1913, Declaring the Same to Be a Legal and Valid Drainage District, and Ratifying, Validating and Confirming the Assessments Made and Bonds Issued For and On Behalf of Said Drainage District.

Be It Enacted by the Legislature of the State of Florida:

Section I. That the creation and organization of a drainage district known as Elkton Drainage District Number One, in St. Johns County, Florida, and including the territory embraced within the following boundaries, to-wit:

The Southeast quarter (SE¼) and Southeast quarter of Southwest quarter (SE¼ of SW¼) of Section Nine (9); South half (S½) of Section Ten (10), Eleven (11) and Twleve (12); all of Section Thirteen (13), Fourteen (14) and Fifteen (15); East half (E½), Southwest quarter (SW¼) and East half of Northwest quarter (E½ of NW¼) of Section Sixteen (16); Southeast quarter (SE¼) of Section Seventeen (17), Northeast quarter (NE¼) of Section Eighteen (18); North half (N½) of Section Twenty-one (21), Twenty-two (22), Twenty-three (23) and Twenty-four (24), all in Township

Eight (8), South of Range Twenty-eight (28) East, according to the Government surveys, said drainage district having been created and organized under the provision of Chapter 6457, Laws of Florida, Acts of 1913, approved June 7th, 1913, is hereby ratified, validated and confirmed, and is hereby declared to be a legal and valid drainage district, with all the power and authority granted by the provision of said law hereinbefore referred to, and all Acts amendatory thereto.

Section 2. That each and every assessment made by the County Commissioners in and for St. Johns County, Florida, upon the lands in Elkton Drainage District Number One, and included within the above mentioned and described territory as set forth in Section One of this Act, for the purposes of securing funds for the payment of expenses incurred in the construction or for the maintenance of the drainage system, or to pay interest upon any bonds issued for and on behalf of said drainage district, or for any other purpose, whether said assessments were authorized by law or not, is hereby ratified, validated and confirmed, and declared to be valid and binding liens upon the lands in said drainage district.

Section 3. That the bonds issued by the Board of County Commissioners of St. Johns County, Florida, for and on behalf of Elkton Drainage District Number One, and being twenty in number, numbered from one to twenty (1 to 20), inclusive, and in the denomination of five hundred dollars (\$500.00) each, are hereby ratified, validated and confirmed, and declared to be valid and binding liens upon the lands in said drainage district.

Section 4. This Act shall take effect upon its passage and approval by the Governor or upon its becoming a law without the approval of the Governor.
