Solid Waste Contracts

Major Departmental Contracts

Residential household garbage, recycling, and yard waste collection agreement with Republic Services for northern St. Johns County.

Expires July 31, 2024

Residential household garbage, recycling, and yard waste collection agreement with Waste Management for southern St. Johns County.

Expires July 31, 2024

Transfer Station operation and solid waste disposal agreement with Waste Management.

Expires July 31, 2029

Residential Collection Service

Current Service Level

Weekly Curbside Collection

- Manual, hand loading of household garbage: Unlimited
- Automated loading of recycling: Hauler provides 35 or 95-gallon carts
- Manual, hand loading of yard waste: Unlimited
- Bulk Waste (Furniture, mattresses, sofas, interior furnishings): Unlimited

Scheduled services

Appliances and white goods as needed by residents



Due Diligence







Due Diligence

1. Waste Hauler Input:

- Conducted interviews with ten waste haulers.
- Provided valuable input on levels of services.
- Recommended long-term contract due to increasing cost of equipment.

2. Customer Service Survey:

- 5,258 residents participated in a county-wide survey.
- 90% of residents were satisfied with the current service levels.
- Reliability was the most important factor in considering residential collection service.

3. Route Survey Project:

- Solid Waste staff conducted a comprehensive set of 5,500 route surveys.
- Route surveys involved a two-week process to gather data on the current participation rates.
- Data collected confirmed that proceeding with current service levels is sustainable for the County.



Contract Options





Contract Options

Request for Proposals 23-32 included two options for residential collection service:

Option 1: Current Service Levels

Weekly Residential Collection Service

- Manual, hand loading of household garbage: Unlimited
- Automated loading of recycling: Hauler provides 35 or 95gallon carts
- Manual, hand loading of yard waste: Unlimited
- Bulk Waste (Furniture, mattresses, sofas, interior furnishings):
 Unlimited
- Appliances and white goods: Scheduled services, as needed by residents.

Option 2: Defined Services

- Weekly Residential Collection Service
- Automated loading of household garbage: Hauler provides 95gallon carts
- Automated loading of recycling: Hauler provides 35 or 95gallon carts
- Manual, hand loading of yard waste: Limited to 2 cubic yards
- Bulk Waste (Furniture, mattresses, sofas, interior furnishings):
 Scheduled services, as needed by residents.
- Appliances and white goods: Scheduled services, as needed by residents.



Contract Options

- The evaluation criteria included an assessment of the company's staff, team qualifications, relevant experience, service approach, and proposed pricing.
- Solicited pricing for the current service level (Option 1) and defined services (Option 2).
- Companies had the option to submit proposals covering the existing north/south service areas and the option to service the entire county.
- Overall a total of seven companies submitted proposals for one or more of the requested options outlined in RFP 23-32.
- The total monthly cost per residential property varied between \$21.22 and \$38.98.

Next Steps





Recommendation for Award

- Recommendation to proceed with FCC Environmental Services.
- □ FCC is the most qualified company in response to RFP 23-32, offering the most competitive overall cost.
- Continue with Option 1, maintaining the current service level without any impact on services for residents.
- □ The proposed agreement includes an initial seven-year term with the option to renew two additional five-year terms.
- □ FCC will provide services to the entire St. Johns County, streamlining operations by eliminating the need for multiple contractors.
- FCC has provided letters of commitment for equipment to ensure the availability of vehicles on the commencement date.
- Opting to maintain current service level (Option 1) would offer the most cost-effective and beneficial solution for residents.



Transition Plan

- Execute contract with FCC Environmental Services.
- Schedule a meeting with FCC to discuss the draft franchise agreement and the transition plan's key concepts.
- Verify the delivery of new collection vehicles and equipment for the contract's commencement.
- Confirm the purchase and delivery of collection carts to residents.
- Implement Trac EZ software for customer service reporting and documentation.
- FCC to identify a local office in St. Johns County and construct a new CNG fueling station.
- Delivery of notice to residents for commencement of residential collection services.

- Will include the purpose of the assessment, total annual revenue, and proposed new rates.
