CONDUIT FINANCING

- → Access to facilities, equipment & tooling quickly & cost-effectively
 - Utilize existing capital efficiently
- A way to pay for equipment or infrastructure that is repaid as a long-term lease

SYNTHETIC LEASING

TAX EFFICIENCIES

- Ad valorem tax (property tax) exemptions

SPECIAL DIRT

Special Dirt is any land owned directly by the federal, state or local government, or instrumentally thereof (airport authority, county industrial authority, public university research park). It provides the ability to secure property and rights to infrastructure from federal, state and local governments for commercial use on behalf of the business.

Space Florida only considers helping secure third-party financing of new building facilities built on "Special Dirt".

The Special Dirt provision does not apply to the acquisition and placement of equipment and tooling.
