

After purchasing Magic Beach in 2010 from a bank under foreclosure, then putting in more than a million dollars of restoration and renovation investment, enthusiasm, and love for many months of restoration and additional Art Deco design improvements along the way, the previous owners, the Jensens, admit they sold the property because they were not able to continue the ongoing, time consuming, expensive maintenance. <u>Having a profitable, sustainable business became questionable.</u>

All windows had to be replaced. The iron-pipe plumbing is inadequate and failing. A fire caused by a neon transformer resulted in months of repair and the Magic rabbits marquee sat at the owners' residence for months. The original

restoration contractor missed some big items, like water pressure equipment to the second floor and drainage pipes along the front of the property.

Although all electrical had been replaced, at the time of ceiling collapse during Hurricane Helene last September it required months of cleanup. The Beachside Caffe could not plug in more than one appliance at a time. The fear of additional unplanned collapsing is still there. The neon lighting is rapidly failing, if you can even find neon repair. There has been minimal maintenance since last summer. One person posting to NextDoor said "We stayed at Magic Beach a year ago. It was very dirty and run down with roaches. We packed up and checked out as quickly as we could."

### **Discovery of Facts vs. Mis-Information**

For many people, the loss and the thought of demolition is every emotional and they don't want to let go and efforts were successful in 2021-2022. Last time, there were 7,000 petition signatures and Save Magic Beach signs on A1A. This time there were 63 postings to NextDoor in one week asking to Save Magic Beach, so the emotions and memories are still there.

Because of my 28 year civic memberships in the community, I was asked by several people individually to determine a direction to go in. One sent me a copy of the demolition application which I had not seen. Importantly, in an effort to discover facts vs. mis-information, I arranged a meeting with the previous owners of Magic Beach to try to determine the physical integrity of the buildings and the history of maintenance. I then interviewed the owners of the Beachside Caffe restaurant for their experience with the collapsed ceiling. The findings uncovered numerous disturbing physical and operational weaknesses.

I must also concur at the same time with the Vilano Beach Main Street organization which has a mission of preservation. The Town Center Guidelines gives the "Vision to create a downtown that celebrates the area's history and maintains a sense of place, while incorporating innovative developments that encourage economic redevelopment, sustainability, and new urbanists design."

VBMS supports revitalization, but needs to remain neutral to the outcome and hope for a win-win outcome. They are providing an opportunity for the developer to publicly present plans and to actively get feedback to those plans which still could change as a result before the cultural review on April 14. The North Beach Community Alliance (NBCA) is tagging along with Main Street. NBCA's mission is "to preserve a healthy quality of life through comprehensive planning, development and infrastructure."

A first failed application to demolish Magic Beach resulted in designation as a County Significant Cultural Resource in 2022. Also it is listed in the State Route A1A Historic Resources Survey.





Dear Members of the St. Johns County Commission,

I am writing to express my deep concern over the potential demolition of the Magic Beach Motel in Vilano Beach. The Magic Beach Motel is not only a culturally significant landmark but also a vital part of the unique "beach vibe" that Vilano Beach and St. Augustine are known for. This vibrant, coastal atmosphere is an essential part of what makes our area so special, and it must be preserved at all costs.

While I recognize that Anastasia Island and St. Johns County are growing, we must be cautious about the kind of development that takes place. The continuous construction of 2- and 3-story buildings and commercial developments is beginning to compromise the character of our beloved beach communities. St. Augustine has built its reputation on its historic charm and coastal beauty, and Vilano Beach should not be transformed into just another stretch of high-rise developments that lack the unique appeal that currently draws visitors and residents alike.

The Magic Beach Motel stands as a reminder of a time when Vilano Beach was a more intimate and relaxed coastal destination. Allowing its demolition to make way for more 2- and 3-story condos and a large commercial building will only further erode the beach vibe that makes this area so unique. It is critical that we do not allow Vilano Beach to follow the same development pattern that has overtaken other parts of the island. If you visit other small beach towns there are moratoriums on height – keeping them one level with very strict guidelines. Why can't this be instituted in St Augustine, particularly VIIano Beach before it gets out of hand?

In addition to the cultural loss, the ongoing pressure on our infrastructure is a growing concern. As more development is approved, our roads, utilities, and services are becoming strained. We must take a more measured approach to growth—one that balances smart development with the preservation of the environment and the quality of life for all who live here.

The developer, Rick, has made it clear that his intention for the property is not to contribute to smart growth but rather to maximize his profit by demolishing the Magic Beach Motel and replacing it with high-density condos and a 5,000-square-foot commercial building. He has openly discussed this plan with the Vilano Beach Main Street Board, and previously, his request to develop the property with the existing footprint was denied. Now, he is seeking approval for demolition to push forward with his original plan, which will further exacerbate the issue of overdevelopment.

Rick the developer has said "the Magic Beach is in disrepair". Well, this is obvious, there has not been any money put towards restoration or renovation, or it has been minimal. But if you look at what was recently done with Haley's Court – they did an incredible job of investing in the property while maintaining the look, feel and vibe of what our Beach Towns should be. To me they are the shining star of Economic Development and Preservation and caring about the impact on the community.

I urge you to consider the lasting impact that the demolition of this culturally significant property will have on our community. It is crucial that we protect the character of Vilano Beach and St. Augustine for future generations. I ask that you reject the proposal to demolish the Magic Beach Motel and work to preserve this important landmark. Let's protect our heritage, our infrastructure, and the very essence of what makes Vilano Beach and St. Augustine so special. Thank you for your time and attention to this critical issue. I trust that you will make the right decision in preserving the character and charm of our community.

I look forward to hearing how you will help Vilano Beach maintain its integrity, your plans on smart growth vs. bigger & better without regard to the community, and next steps as you see them.

And I am happy to work with Commissioner Taylor on this important initiative.
