# RESOLUTION 2002- 208

RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA: CHANGING NAME OF EXISTING WEST AUGUSTINE COMMUNITY REDEVELOPMENT AGENCY TO ST. JOHNS COUNTY COMMUNITY REDEVELOPMENT AGENCY: THE BOARD OF COUNTY COMMISSIONERS DECLARING ITSELF TO BE THE BOARD OF THE ST. JOHNS COUNTY COMMUNITY REDEVELOPMENT AGENCY; INCORPORATING INTO ST. JOHNS COUNTY COMMUNITY REDEVELOPMENT AGENCY THE BOUNDARIES OF THE WEST AUGUSTINE COMMUNITY REDEVELOPMENT AREA AS PREVIOUSLY DESIGNATED IN RESOLUTION 2000-146, THE BOUNDARIES OF VILANO BEACH COMMUNITY REDEVELOPMENT AREA AS PREVIOUSLY DESIGNATED IN RESOLUTION 2002-184, AND THE BOUNDARIES OF FLAGLER ESTATES COMMUNITY REDEVELOPMENT AREA AS PREVIOUSLY DESIGNATED IN RESOLUTION 2002-185: APPROVING THE COMMUNITY REDEVELOPMENT PLANS FOR VILANO BEACH AND FLAGLER ESTATES COMMUNITY REDEVELOPMENT AREAS; AND PROVIDING AN EFFECTIVE DATE.

## RECITALS:

WHEREAS, the Board of County Commissioners of St. Johns County, Florida (the "Board") finds it desirable to have a Community Redevelopment Agency within the boundaries of the County which shall address the needs of redevelopment areas within the County; and

WHEREAS, there currently exists three separate Community Redevelopment Areas within St. Johns County, those being West Augustine Community Redevelopment Area established in Resolution 2000-146, Vilano Beach Community Redevelopment Area established in Resolution 2002-184, and Flagler Estates Community Redevelopment Area established in Resolution 2002-185; and

WHEREAS, the West Augustine Community Redevelopment Agency established in Resolution 2000-146 contains only the boundaries of West Augustine Community Redevelopment Area; and

WHEREAS, the Board finds it more efficient to rename the existing Community Redevelopment Agency to St. Johns County Community Redevelopment Agency and to incorporate into it the boundaries of the individual redevelopment areas within the County; and

WHEREAS, the Board finds it appropriate to declare itself the governing board of the renamed St. Johns County Community Redevelopment Agency, as it has been the governing board of the West Augustine Community Redevelopment Agency; and

WHEREAS, the Board, as governing board of St. Johns County Community Redevelopment Agency, finds it desirable to approve the Vilano Beach Community Redevelopment Plan and the Flagler Estates Community Redevelopment Plan.

WHEREAS, in accordance with applicable provisions of section 163, Part III, Florida Statutes, proper and timely notice has been given to the public notifying them of this proposed resolution and of the public hearing for its consideration, and said public hearing was held pursuant to the published notice described.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

- 1. The above Recitals are hereby accepted as findings of fact and incorporated by reference herein.
- 2. Pursuant to the powers granted under and, in accordance with, section 163.357, Florida Statutes, and any other applicable sections of Chapter 163, Part III, Florida Statutes, as amended, the Board hereby takes the following action:
  - (a). Renames the West Augustine Community Redevelopment Agency to the St. Johns County Community Redevelopment Agency;
  - (b). Declares itself to be the governing body of the St. Johns County Community Redevelopment Agency; and
  - (c). Incorporates into the St. Johns County Community Redevelopment Agency the boundaries of West Augustine Community Redevelopment Area as established in Resolution 2000-146, and the boundaries of Vilano Beach Community Redevelopment Area as established in Resolution 2002-184, and the boundaries of Flagler Estates Community Redevelopment Area as established in Resolution 2002-185.
- 3. Pursuant to the powers granted under and, in accordance with, section 163.360, Florida Statutes, and any other applicable sections of Chapter 163, Part III, Florida Statutes, as amended, the Board hereby approves the Community Redevelopment Plans for the Vilano Beach Community Redevelopment Area and the Flagler Estates Community Redevelopment Area based on the following findings:
  - (a). A feasible method exists for the location of families who will be displaced from the community redevelopment areas in decent, safe, and sanitary dwelling accommodations within their means and without undue hardship to such families;
  - (b). The community redevelopment plans conform to the general plan of the County as a whole;
  - (c). The community redevelopment plans give due consideration to the utilization of community policing innovations, and to the provision of adequate park and recreational areas and facilities that may be desirable for neighborhood improvement, with special consideration for the health, safety, and welfare of children residing in the general vicinity of

the site covered by the plans;

- (d). The community redevelopment plans will afford maximum opportunity consistent with the sound needs of the County as a whole, for the rehabilitation or redevelopment of the community redevelopment areas by private enterprise; and
- (e). The community redevelopment plans and resulting revitalization and redevelopment for a coastal tourist area that is deteriorating and economically distressed will reduce or maintain evacuation time, as appropriate, and ensure protection for property against exposure to natural disasters.
- 4. The Board reaffirms the Community Redevelopment Plan for the West Augustine Community Redevelopment Area previously approved in Resolution 2001-226.
- 5. This Resolution shall take effect immediately upon passage by the Board of County Commissioners of St. Johns County.
